

Sebapharma Mediapool terms of use

1. Scope of use

Use of this website is only permitted with adherence to these terms. By logging in you agree to the applicable version of the terms of use. Our web service is intended exclusively for companies.

2. Services

Information will definitely be made available for download from the Mediapool service. Sebapharma reserves the right to suspend access to the entire website or parts thereof at any time. Due to the nature of the Internet and computer systems, we are unable to guarantee uninterrupted availability of the website.

3. Registration and password

Access to the Mediapool service is password-protected to ensure the security of business dealings. Registration is not an automatic right. Sebapharma is entitled to revoke access rights at any time and without explanation by blocking the access data. This can occur if the user, for example:

- Has provided false details during registration
- Has violated requirements with respect to access details and these conditions
- Has not logged into the Mediapool service for an extended period of time

When registering, the user is obligated to provide truthful information and to notify Sebapharma without delay of any changes that may be made to them. The user will ensure that he/she is able to access the e-mails which are sent to the address provided by him/her. Following successful registration, the user will receive a user name and password (referred to as "user data" from this point onwards). The user will ensure that his or her user data cannot be accessed by third parties. After each user session, the user must log out of the password-protected area.

If the user becomes aware that a third party is misusing his or her user data, he/she is obligated to immediately notify Sebapharma in writing and by e-mail in advance where applicable. Following receipt of this information, Sebapharma will block access by means of this user data. The block can only be lifted if the user makes a separate application to Sebapharma or re-registers.

The user may submit a written request to have his/her registration cancelled at any time. In such cases, Sebapharma will delete all user data and other personal information from its database as soon as this data is no longer needed.

4. User rights

Sebapharma grants the user a non-exclusive and non-transferrable right to use the data made available in the Mediapool service in a manner which is commensurate with Sebapharma's intentions in providing such data. The user must only give third parties access to this data if doing so is also commensurate with Sebapharma's intentions.

5. User obligations

When using the Mediapool service, the user must not

- Infringe upon intellectual property rights or other property rights
- Transmit content containing viruses, so-called "Trojan horses", or other programs that can damage software
- Input, store or send unauthorised hyperlinks or content, particularly if these hyperlinks or this content violates confidentiality agreements or the law
- W Distribute advertising or unsolicited e-mails ("spam") or false warnings against viruses, malfunctions or similar, or invite participation in contests, snowball systems, chain letters, pyramid games, and similar actions.

Sebapharma can bar access to its web site at any time, particularly if the user violates his/her obligations under these terms and conditions.

The Mediapool website may contain hyperlinks to third-party websites. Sebapharma neither assumes liability for the content of these websites nor adopts any of their content as its own. The user accesses these websites at his/her own risk.

7. Other areas or responsibility

Data is stored exclusively for the purpose of use in our Mediapool service, and is not for advertising purposes.
